The Company bought back and extinguished a total of 11,57,419 (Eleven Lakhs Fifty-Seven Thousand Four Hundred Nineteen Only) of its equity shares at a price of Rs. 211/- (Rupees Two Hundred Eleven Only) per Equity Share. November 01, 2021, and Shri Abhishek Kapoor was appointed as a Chief Financial Officer and Key Managerial Personnel of the Company w.e.f. November 01, 2021.
- 13. Appointment of auditors as per the provisions of section 139 of the Act. However, there was no instance requiring re-appointment or filling up of a casual vacancy of auditors.
